exhibit runs march 1 thru march 19

ArtServe announces an open call to artists, including photographers, to submit entries to its third annual 'twelve by twelve - the collective', an exhibition of small scale works of art that are precisely 12 inches x 12 inches. This exhibit will once again unite the visual arts in Broward County and be held at ArtServe march 1 thru march 19, 2010.

ELIGIBILITY

artists working in 2d and 3d with any medium in the United States and Canada, may submit up to 3 pieces of artwork to be considered for this exhibit. Work that has been exhibited previously at twelve by twelve is not eligible.

ENTRY SPECIFICATIONS

works submitted must be precisely "twelve by twelve" in all directions (this includes the frame for two dimensional works, jewelry may be submitted in 12" x 12" shadowboxes or may be mounted to a canvas). there are no media restrictions. the theme is open. canvas to be gallery wrapped with no visible staples. sawtooth hangers only placed 1" from top of artwork. Artwork that does not meet these specifications will not be accepted.

ENTRY FEE

i. ArtServe members - a **\$15** entry fee will be charged for 3 pieces of artwork entered. artists may submit as a member of more than one organization, but are limited to three pieces per organization.

ii. participating visual arts group members - a **\$25** entry fee will be charged for 3 pieces of artwork entered. artists may submit as a member of more than one organization, but are limited to three pieces per organization.

iii. general public - a **\$35** entry fee will be charged for 2 pieces of artwork entered

FUNDRAISER

40% of the intake fee will be donated back to the group that the artist enters under.

ACCEPTED WORKS

artwork that is accepted will be hung in a grid format as part of an installation. the ArtServe curator and gallery committee will have final say on content and placement.

ARTWORK THAT DOES NOT MEET THE 12"X12" FORMAT WILL NOT BE ACCEPTED.

PRICE OF ARTWORK

all artwork will be sold at a retail price of \$200. if sold the artist will receive \$150.

SCHEDULE

press photographs **january 29, 2010**
participants may email up to three photographs (300 DPI) of the artwork they plan to enter into the show to byrons@artserve.org.

intake **february 20, 2010**
intake will be on saturday from 10am - 2pm at ArtServe, 1350 east sunrise boulevard, fort lauderdale fl, 33304. participating organizations will be required to be present to assist their members at intake in the ArtServe Gallery.

opening reception **march 12, 2010**
an opening reception will be held on friday, march 12, 2010 from 6-8pm. artists are encouraged to attend the "info exchange expo" for networking & exhibit opportunities

info-exchange expo **march 12, 2010**
in conjunction with the opening reception, participating arts organizations will present member benefits, promotional materials, exhibition opportunities and gallery schedules and county sponsored loan, grant and public art opportunities in the ArtServe auditorium.
